## ***Maintenance Therapy: Effective Operationalizing of the Regulations***

Much discussion and interest has been generated since ruling on Jimmo v Sebelius has occurred. However, the issue of maintenance therapy has been a component of the Medicare Part A Home Health Benefit long before this court case. Currently, many home health agencies, as well as their therapy staff, have limited or no experience in addressing the issue of maintenance therapy.

Concerns and questions frequently presented to Kornetti & Krafft Health Care Solutions regarding maintenance therapy in the home health setting focus on proper beneficiary identification, supportive documentation, therapy utilization and billing procedures.
