Webinar Overview:

As home health agencies learn how to achieve the best outcome at the lowest cost, we find best practice PDGM leverages the skills of each clinical discipline and office-based care managers. During the shift to PDGM, therapy utilization came under intense scrutiny, despite the role of therapy remaining unchanged. What has changed is the manner in which the interdisciplinary team approaches care planning, which yields solid clinical and financial outcomes.
