Interdisciplinary Care Planning: Optimizing Therapy under PDGM

Kornetti & Krafft Health Care Solutions provides an engaging webinar that addresses the paradigm shift from volume- to value-based care for clinicians in the home health setting both therapy and nursing strategies will be shared. This session focuses on case management in a patient-driven acuity model of reimbursement with special attention paid to specific chronic disease populations commonly encountered in this setting. Both in-person and virtual visit options will be explored. Attendees will receive current regulatory guidance and expert content, as well as tools and resources supporting clinical care coordination, decisioning and defensible documentation.

Objectives

- Ensure documentation throughout the record shows intentionality with respect to patient centered care planning and attention to outcome measures.
