Advocacy

Oregon Nurses Association Proposes Big Changes Ahead for Oregon Home Health & Hospice Agencies in 2025!

Are you prepared for the potential impact of new safety and staffing regulations? Proposed staffing legislation in 2025 could reshape the future of your agency. If passed, staffing requirements could mean:

- Mandatory staffing committees for **all** disciplines not just nurses
- Hefty fines for agencies unable to comply
- Possible closures and reduced access to essential care services

ONA is also pushing forward a safety package that would require you to pay injured workers to take time off from work outside of the workers comp system.

OAHC successfully fought off similar staffing legislation in 2023, but the fight isn't over. Your OAHC lobbying team is working hard to mitigate potential damage and fight back against onerous legislation. But we need your support to protect your agency!

National Representation

OAHC is a member of two national organizations representing home care - National Alliance for Care at Home (Alliance) and Council of State Home Care and Hospice Associations (Council).
